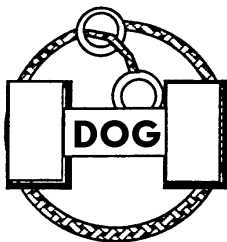

*These armband numbers first denote the class (i.e., Rally Advanced A = RAA), your dog's jump height (i.e., 16), and the order within each jump height (1, 2, etc.) For instance, RAA16-02 = dog #2 in the Rally Advanced A 16-in. group.

Warmup Ring: Red Ring, available in 5-minute time slots. Sign up at ringside.

Judges will take a 45-minute lunch break at their discretion. Armbands will be at your ring and catalogs will be available at the Secretary's table. Trial hours are 7:00 AM to 3:00 PM. Dogs may arrive any time prior to judging.

Please note: Vehicles may be allowed to drive to the trial site for unloading, but must be moved to the parking lot by 7:45 AM. No vehicles will be permitted to drive into the trial area for loading or unloading while judging is in progress. Thank you for your cooperation.

Directions to trial:

From north or south on I-880, exit eastbound on Jackson Street and turn right at the first stoplight. You will be on Santa Clara, which becomes Harder. Stay on Harder to the campus, go up the hill, pass two stop lights, and turn left at the next stop sign. Park in Lot K.
